Sub: - Grant of retrospective effect to the promotion of Mr Abdul Rashid Wani.
ASK, R.No. 3358- Notice for inviting of objections thereof.

Whereas, Mr Abdul Rashid Wani, R.No. 3358 was initially appointed as Depot Assistant carrying substantive pay scale of Rs 630-940 revised Rs 2550-3200 on 23.05.1985.


Whereas, Mr. Wani has qualified Matric in 2003 and produced the certificate in 11/2006. His case was put before next DPC held on 08.10.2007 for consideration and he was dropped for non furnishing of work and conduct report.

Whereas, reportedly it came to the notice that an amount of Rs: 39,627/= was outstanding against him and subsequently his case was again put before the DPC held on 24.01.2009 in view of liquidation of outstanding amount and work and conduct certificate furnished by the concerned Assistant Director, he was cleared for promotion as Jr. Storekeeper in substantive pay scale of Rs 775-1025 revised Rs 2610-3540 w.e.f: 24.01.2009 and subsequently was promoted as assistant Storekeeper carrying the pay scale of Rs 950-1500 revised Rs 3050-4910 by DPC held on 20.11.2010.

Whereas, Mr Wani made representation stating therein that in view of clarification from Accounts section, he may be treated promoted from 08.10.2007 and it was decided in the DPC meeting that the promotion be granted in favour of Mr Wani notionally w.e.f: 08.10.2007.

Whereas, on the perusal of records it has been found that in case the plea of Mr Wani is considered he has to be placed at S.No: 54/A below Mr Showkat Hussain Banday SK R.No. 3352 appearing at S.No. 54 and above Mr Shakeel Ahmad Khan SK R.No. 2829 appearing at S.No. 55 in the seniority list finalized vide this office order No. DFCS&CAK/Adm/B-X-306 dated: 19.09.2017.

Now before taking further action in the matter, objections from aggrieved officials, if any, are invited which shall reach to this office within a period of ten(10) days and beyond the stipulated time period no objection shall be entertained.
