**Sub: - Fixation of rates of poultry and poultry products.**

**NOTIFICATION**

**Dated, Srinagar 15th of July, 2022**

In view of a recent reduction in the prices of the Poultry and Poultry products witnessed in respect of Kashmir Division and in supersession of all previous notifications issued on the subject and in exercise of the powers conferred upon me under Essential Commodities Act, 1955; I, Dr. Abdul Salam Mir, Director – Food, Civil Supplies & Consumer Affairs Department, Kashmir hereby revise and re-fix the maximum rate of poultry and poultry products as under: -

=> **At Farm Rate (inclusive of Farmer's profit) :-**

1. Broiler (Live) per Kg. = Rs. 120/- (Rupees one hundred & twenty only)

=> **Wholesale Price (Inclusive of Dealer's profit):-**

1. Broiler (Live) per Kg. = Rs. 132/- (Rupees one hundred & thirty two only)

=> **Retail Price:-**

1. Broiler (Live) Per Kg. = Rs. 140/- (Rupees one hundred & forty only).

Retail Price for Eggs = Rs. 60/- per dozen.

This notification shall have immediate effect.
