Broiler (Live) per Kg.

= Rs.130/- (Rupees one hundred thirty only)

2. Parent (Live) per Kg.

= Rs.140/- (Rupees one hundred forty only)

3. Egg (Per dozen)

= Rs.60/- (Rupees sixty only)

This notification shall have immediate effect. Besides, the wholesale dealers are directed to issue proper invoice (printed) on spot for each transaction in favour of the retail buyers explicitly indicating therein the rate per Kilogram/Dozen for each item.
