NOTIFICATION

Dated, Srinagar 21st of April, 2022


Consequent upon the decisions taken in the meeting and in supersession of all previous notifications issued on the subject and in exercise of the powers conferred upon me under Essential Commodities Act, 1955; I, Dr. Abdul Salam Mir, Director - Food, Civil Supplies & Consumer Affairs Department, Kashmir hereby revise and re-fix the maximum rate of poultry and poultry products as under: -

1. Broiler (Live) per Kg. = Rs. 130/- (Rupees one hundred thirty only)
2. Parent (Live) per Kg. = Rs. 120/- (Rupees one hundred twenty only)
3. Egg (Per dozen) = Rs. 50/- (Rupees fifty only)

This notification shall have immediate effect.
