Sub: - Fixation of rates of poultry and poultry products

NOTIFICATION

Srinagar, dated the 27th of March, 2023

In supersession of all previous notifications issued on the subject and in exercise of the powers conferred upon me under Essential Commodities Act, 1955; I, Dr. Abdul Salam Mir, Director - Food, Civil Supplies & Consumer Affairs Department, Kashmir hereby revise and re-fix the maximum rate of poultry and poultry products as under: -

1. Broiler (Live) per Kg. = Rs.130/- (Rupees one hundred thirty only)
2. Parent (Live) per Kg. = Rs.140/- (Rupees one hundred forty only)
3. Egg (Per dozen) = Rs.60/- (Rupees sixty only)

This notification shall have immediate effect. Besides, the wholesale dealers are directed to issue proper invoice (printed) on spot for each transaction in favour of the retail buyers explicitly indicating therein the rate per Kilogram/Dozen for each item.
