
Consequent upon the relaxation conveyed by General Administration Department /Administrative Department vide communications referred to above and satisfactory Character and Antecedents report from Criminal Investigation Department through online mode vide form No. 97725 dated 19.03.2024, sanction is hereby accorded to the temporary appointment of Mr. Mohd Amin Mir S/o Nazir Ahmad Mir (deceased Watchman) R/O Awoora, Tehsil Trehgam District Kupwara as Multitasking Staff (Class-IV) in the pay level of Rs. 14800-47100 (SL 1) in District cadre Kupwara against the available vacancy of MTS in terms of J&K Compassionate appointment rules notified under SRO 43 of 1994;

The appointee shall report to Assistant Director FCS&CA Kupwara within a period of twenty-one (21) days from the date of issuance of this order and shall be allowed to join only on production of following Documents/ Certificates in original to be verified subsequently:-

- i. Academic/Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Health Fitness Certificate from the Chief Medical Officer of concerned District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Dependent Certificate issued by the competent authority.
- vi. Affidavit from appointee for maintenance of the dependents.
- vii. Affidavit from other dependents for No objection to the appointment of the applicant.
- viii. All other relevant documents as are required under SRO 43/1994.

The appointment of the above candidate shall further be subject to the following conditions: -

- a. That the salary of the appointee shall not be drawn and disbursed unless the satisfactory verifications/reports in respect of genuineness of Qualification/ Date of Birth and other documents are received from the concerned Authorities/Agencies.
- b. That the appointee shall be on probation for a period of two years.
- c. That the appointment of the candidate shall be governed by the "New Pension Scheme" as Notified vide SRO-400 of 2009 dated 24.12.2009.
- d. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District

Employment & Counselling Centre (DECC) of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/ enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.


- e. That the inter-se-seniority of the appointee shall be determined as per the rules.
- f. That the appointee shall give an undertaking in the shape of an affidavit duly attested by Judicial Magistrate, 1st Class to the effect that if upon verification the genuineness of the documents submitted by him is found to be fake / forged, the claim of the appointee for appointment as MTS shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- g. That the appointment of the above appointee shall be subject to outcome of writ petition (s), if any, pending before Competent Court of law.
- h. That if the candidate fails to join within a period of 21 (twenty one) days from the date of issuance of this appointment order, he shall forego his right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice in terms of the Circular No. 08-JK (GAD) of 2019 dated 04.12.2019 issued by General Administration Department.
