Consequent upon receipt of satisfactory Character/Antecedents verification report from Criminal Investigation Department J&K vide letters referred to above, recommendations made by J&K Service Selection Board communicated vide their letter No. SSB/Secy/Sel/2021/7046-53 dated 14.10.2021 and Administrative Department's letter referred to above read with Govt order No. 32 JK(FCS&CA) of 2024 dated 31.05.2024, sanction is hereby accorded to the temporary appointment of Mr. Sahil Pandita S/o Manmohan Pandita R/o Gund Gushi, Kupwara District Kupwara Depot Assistant (Multitasking Staff) under RBA carrying substantive pay level of Rs.14800-47100 (SL-1) under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

The appointment of the appointee shall be subject to the following conditions:-

- a. That the emoluments of the appointee shall be governed under S.O 194 dated 17.06.2020 as extended vide government order No. 586 JK GAD of 2021 dated 17.07.2021.
- b. That the appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, genuineness of the qualification, migrant, domicile and category (if any) certificates from the concerned issuing authority are found fake/forged, the claim of the appointee for appointment shall be deemed to have been cancelled abi-initio.
- c. The salary of the appointee shall be drawn and disbursed by the concerned Drawing and Disbursing Officer only after receipt of satisfactory report in respect of documents as mentioned at (b).
- d. The in-terse-seniority of the appointee shall be as per the order as it exist in the selection list as communicated by J&K Service Selection Board.
- e. The appointment and other terms and conditions shall be governed by SRO 412 of 2009 dated 30.12.2009 issued by Revenue Department.
- f. The appointment of the candidate shall be governed by the "New Pension Scheme" notified vide SRO-400 of 2009 dated 24.12.2009.
- g. The appointment is subject to the outcome of any writ petitions (s), if any, pending before any court of competent jurisdiction.
- h. That if the candidate has taken loan DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish proprietorship of unit/enterprise and also stakes, if any, in self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan in suitable EMIS to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from concerned appointee regarding both relinquishment proprietorship and stakes, if any, in such a self-employment until/ enterprise and recovery to be made and also monitor its

The appointee shall report to the Assistant Director Kupwara - Food, Civil Supplies and Consumer Affairs, Kashmir within a period of (21) twenty — one days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates (in original) wherever applicable to be verified subsequently:-

- 3. Domicile Certificate.
- 4. Health Certificate from the concerned Chief Medical Officer.
- 5. Migrant certificate
- 6. Non-Migrant Certificate (For Non-Migrant Kashmiri Pandits) from concerned Revenue authority
- 7. Category certificate, if any.

In case the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forfeit his right and his appointment shall be deemed to have been cancelled ab-initio without any further notice as per Circular No. 08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department.
