As recommended by the Departmental Promotion Committee (DPC) in its meeting held on 03.02.2021, sanction is hereby accorded to the promotion of twenty-nine (29) Class-IV officials as detailed in the annexure to this order carrying substantive pay level of Rs. 14800-47100 (SL-1) as Assistant Storekeeper-cum-Clerk in the pay level of Rs. 19900-63200 (L-2).

This order is issued subject to outcome of departmental enquiry/FIR/writ petition, if any, pending disposal in the Court of Law and subject to receipt of vigilance clearance from Administrative Department.

The concerned Drawing and Disbursing Officer shall ensure that there is nothing outstanding against the promoted official on account of Govt outstanding / food grains nor is he/she involved in any defalcation or other case of omissions/commissions/ Crime / Vigilance cases etc.

If on later stage, it is established that the promoted official is involved in any of the above cases, the said official shall be deemed to have been reverted to his / her original position and the instant promotion order shall be deemed to have been withdrawn ab-initio in his / her favour.

This order shall take effect notionally from 02.02.2021 and substantively with immediate effect.
