Consequent upon the requirement of Foodgrains (Rice, Wheat and Sugar) furnished by the Zonal Officer Special Zone Srinagar and the request made for issuance for Foodgrains in favour of Political Migrant families from April 2024 onwards, Assistant Director Stores/ Mills FCS&CA Kashmir is hereby authorized for:

1. Procurement/ lifting of Foodgrains to the extent of **392.85 Qtls of Rice** and **87.30 Qtls of Wheat** from FCI at OMSS (D) rates for Political Migrant families for the period **April 2024 to December 2024**.
2. Release of Foodgrains to the extent of **392.85 Qtls of Rice** and **87.30 Qtls of Wheat** from Stores and allocation of same in favour of Assistant Directors of FCS&CA Srinagar North/ South and Budgam as per the station wise breakup given in below **Table "A"** below.
3. Release of **11.70 Qtls of Sugar** from Stores and allocation of same in favour of Assistant Directors of FCS&CA Srinagar North/ South and Budgam as per the station wise breakup given in below **Table "A"**.
