Whereas, Mr. Hilal Ahmad Shah, Storekeeper R.No.4046 has been cleared for promotion as Tehsil Supply Officer by the Departmental Promotion Committee meeting held on 23.10.2019;

Whereas, the orders for promotion in his favour as Tehsil Supply Officer could not issued due to non-receipt of vigilance clearance;

Whereas, Mr. Hilal Ahmad Shah represented before this office stating therein that he was due for promotion as Tehsil Supply Officer in the DPC held on 23.10.2019, however, he was not considered due to non-receipt of vigilance clearance in his favour which was later on received, but formal promotion order in his favour is yet to be issued;

Whereas, the grade of Tehsil Supply Officer carrying substantive pay level of Rs.35400-112400 (L-6) was released in his favour w.e.f. 17.08.2020 vide order No.149-DFCS&CAK of 2021 dated 08.09.2021;

Whereas, Mr. Hilal Ahmad Shah again represented before this office stating therein that he was due for promotion as Tehsil Supply Officer in the DPC held on 23.10.2019, and number of officials who are junior to Mr. Hilal Ahmad Shah have been granted due date/retrospective effect i.e. w.e.f. 01.10.2019;

Whereas, as per the records, his counterparts/Jr. Counterparts have been cleared for promotion as Tehsil Supply Officer w.e.f. 01.10.2019 as per DPC decision dated 23.10.2019;

Now, therefore in view of above, to protect his seniority and as recommended by DPC dated 23.10.2019, it is hereby ordered that the promotion granted to Mr. Hilal Ahmad Shah, R.No.4046 as Tehsil Supply Officer vide order No.149-DFCS&CAK of 2021 dated 08.09.2021 w.e.f. 17.08.2020 shall take effect from 01.10.2019 notionally i.e. the date his junior counterparts have been cleared/promoted as Tehsil Supply Officers.
