Subject:-Allocation of Foodgrains under NFSA for the purpose of Inter State/
National Portability.

Dated:-27-08-2022.

Consequent upon the allotment made by the Administrative Department vide No. CAPD/Plan/ONORC/2020-21 dated:- 23-08-2022, Assistant Director FCS&CA Stores/Mills is hereby authorized to lift/ procure foodgrains to the extent of 102.02 Qtls of Rice and 43.00 Qtls of Wheat from FCI out of central allocation of November 2022 under Interstate National Portability i.e. ONORC (NFSA) as directed by the Administrative Department for its subsequent release in favour of Assistant Directors of FCS&CA Kashmir division as per the district wise breakup given in Annexure "A" to this order.

The Assistant Directors of FCS&CA Kashmir division shall ensure lifting/ dispatch of entire released quantity for distribution in the month of August 2022 amongst the deserving beneficiaries through PoS devices only under Interstate National Portability ONORC (NFSA) strictly as per the directions of the Administrative Department specifically in respect of distribution ratios i.e. 70.99 : 29.01 to be adopted for Rice and Wheat respectively duly conveyed vide communication referred hereinabove.

The Assistant Directors shall ensure mass publicity at grass root level to promote the portability for maximizing transactions through the concerned field officers/ officials and other functionaries.

The Assistant Directors shall ensure proper recording of receipts and distribution and necessary reconciliation at all levels on monthly basis (transaction wise) so that monthly reports are submitted as and when sought by Administrative Department.

The above allocation is subject to the fulfillment of other terms and conditions conveyed from time to time.
