
Consequent upon receipt of satisfactory Character and antecedents report from Criminal Investigation Department J&K. Srinagar vide letter referred to above sanction is hereby accorded to the temporary appointment of Mr. Shahnaz Rehman S/O Late Abdul Rehman Teeli (deceased Depot Assistant) R/o Khansahib Budgam as watchman Class-IV (MTS) in district cadre Budgam carrying pay level of Rs.14800-47100 (SL-1) against the available vacancy in terms of J&K Compassionate Appointment Rules 1994 issued under SRO-43 dated 22.02.1994.

The appointee shall however be allowed to join on production of following documents/ certificates in original: -

1. Character / antecedents report.
2. Academic Qualification Certificate
3. Date of Birth Certificate
4. Domicile Certificate
5. Health fitness certificate
6. Dependent certificate
7. No objection Certificate from DIC/DECC concerned
8. Affidavit from appointee for maintenance of the dependents of the deceased
9. Affidavit from other dependents for NOC


The appointment of the appointee shall further be subject to the following Conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that If on Verification, genuineness of the qualification/ other certificates from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Class-IV (Watchman) shall be deemed to have been cancelled abi-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a Satisfactory report in respect of (a) is received in his favour.
- c. The appointee shall be initially on probation for a period of two (02) years.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.



- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment and his appointment shall be deemed to have been cancelled ab-initio without any further notice as per Circular No.08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department.

The appointee shall report to the Assistant Director Budgam - FCS&CA Department, Kashmir for further duties within a period of twenty-one days from the date of issuance of this order.
