Sub: - Appointment of candidates for the posts of Assistant Storekeeper-cum-Clerk (Food, Civil Supplies and Consumer Affairs Department) Divisional Cadre Kashmir.

Whereas, Administrative Department vide letter No.CAPD/Estt/59/2011 dated 10.07.2017 forwarded list of candidates selected by J&K Service Selection Board Srinagar vide letter No. SSB/Secy/201/5298-5304 dated 09.06.2017 against the post of ASK-cum-Clerk;

Whereas, **seven (7)** candidates were selected in **S.T** category whereby recommendation of **two (02)** posts was kept withheld and **two (02)** candidates were figuring in waiting list against whom recommendation of one incumbent was kept withheld;

Whereas, accordingly formal appointment order was issued in favour of <sup>7</sup>sixty – two (62) candidates vide order No. 282 DFCS&CAK of 2017 dated 18-07-2017, however only nineteen (19) candidates joined within stipulated time and first notice was issued asking the non-joining selected candidates to report vide No. DFCS&CAK/Adm/B-X-25/2017 dated 14.08.2017;

Whereas, second notice was issued asking the forty two (42) non-joining selected candidates to report vide No. DFCS&CAK/Adm/B-X-25/2017 dated 14.09.2017;

Whereas, they failed to join and appointment of forty one (41) candidates was cancelled vide order No. 456 DFCS&CAK of 2017 dated 16.10.2017 which includes twenty four (24) candidates in O.M category, ten (10) candidates in R.B.A category, Five (05) candidates in S.C category, one (01) candidates in S.T category;

Whereas, Administrative Department vide letter referred above forwarded a copy of order No. 77 SSB of 2018 dated 19.01.2018 of J&K Service Selection Board Srinagar wherein the withheld selection of **two (02) S.T** candidates was cancelled/withdrawn abinitio and intending department to operate waiting list;

Whereas, appointment order in respect of Mr. Zahid Ahmad S/o Mohd Saleem Gujjar Pathan R/o Chunt Waliwar Lar Ganderbal falling in waiting list of S.T category at S.No. 01 has been issued vide order No. 482 DFCS&CAK of 2017 dated 01-11-2017;

Now, therefore, in view of instructions conveyed by the Administration Department sanction is hereby accorded to the temporary appointment of Mr. Huraib Maqbool Lone S/o Mohd Maqbool Lone R/o Badwan, Gurez District Bandipora who was figuring at S.No. 02 in (ST) category in the waiting list detailed in Annexure 'A' to the above referred letter as Assistant Storekeeper-cum-Clerk in the pay scale of Rs.5200-20200 + Grade Pay Rs.1900 against the resultant vacancies that have become available by non-joining of the candidates selected in main list.

The appointment of the candidate is subject to production of following certificates in original and the verification thereof from the concerned quarters: -


1. Academic Qualification Certificate
2. Date of Birth Certificate
3. State Subject Certificate
4. Loan/Stipend if any received has been refunded into the treasury in full
5. No Loan Certificate under self employment from the concerned department
6. Health Fitness Certificate from concerned CMO
7. Character/Antecedents Certificate
8. Two (2) recent Passport Size photographs duly attested
9. Category Certificate in case of category candidates from the competent authority as required under reservation rules

The appointment of the candidates will be subject to the following conditions: -

1. The candidate shall give an undertaking in the shape of an affidavit duly signed by the Judicial Magistrate 1<sup>st</sup> Class to the effect that in case any adverse report about his/her character and antecedents is received from Police/CID, J&K, he/she shall have no right to claim for his/her appointment as Assistant Storekeeper-cum-Clerk and his/her appointment, as such, shall be deemed to have been cancelled ab-initio;
2. In case any certificate/document of the appointee is proved fake/fictitious/not genuine his/her appointment order shall be cancelled ab-intio and criminal proceeding against such candidate (s) shall be initiated.
3. Salary of the appointee shall not be drawn and disbursed unless satisfactory report about his/her character and antecedents is received from the Inspector General (CID), J&K.

The appointees shall remain on probation for a period of two years and confirmation whereof will be issued only after their satisfactory performance. He will report to the office of Assistant Director FCS&CA Deptt Bandipora for further duties.

The seniority of the appointees shall be determined as per the prescribed norms/ rules.
