Consequent upon the increase in the rates of PDS SKO by the Oil Marketing Companies, and in supersession of previous notifications issued on the subject by this Directorate and in exercise of the powers vested in me under clause 2 (B) of kerosene (Fixation of Ceiling Price) Order 1970, I, **Nisar Ahmad Wani, Director, Food, Civil Supplies & Consumer Affairs Kashmir**, hereby revise and refix the sale rate of PDS SKO at Rs. 22.55 per litre applicable within the Municipal Limits of Srinagar District for the month of May, 2017. The rate so arrived has been determined in the manner as indicated in the table below:-

In case of any default by any dealer, action as warranted under section 3/7 of the Essential Commodities Act, 1955 shall be invoked against the erring dealer.
